Members noted the decision notices. However, members were disappointed with the response of Wealden District Council regarding WD/2018/1288/F 19 Jeffreys Way and felt that this had set a dangerous precedent which would eventually detract from the open plan appearance of the estate. It was also mentioned that this is contradictory to other recent applications where the applicant had been refused permission and consequently they had been instructed to remove their fence.
