## 4.0 MINUTES

4.1 Minutes of the meeting held on 22<sup>nd</sup> March 2021

# P48.04.21 It was RESOLVED that the minutes of the Extraordinary Plans Committee of the 22<sup>nd</sup> March 2021, be taken as read, confirmed as a correct record and signed by the Chairman.

## 5.0 PLANNING APPLICATIONS

WD/2020/2112/F LAND ADJOINING 10 BROWNS PATH, UCKFIELD, TN22 1LH Proposed new dwelling.

## **P49.04.21** It was **RESOLVED** to **strongly object** to the application on the following grounds:

- Although it was noted the design build was smaller than the previous application, it was maintained that the size of the build would be tight within the size of the plot;
- Infilling would be detrimental to the open plan design and layout on the Manor Park Estate to which Uckfield Town Council have always been opposed;
- The proposed dwelling would detrimentally affect the street scene, traffic flows and parking;
- We would support the comments of objection made by the Tree and Landscape Officer of Wealden District Council, which state that the

development would present an unsustainable relationship between retained and TPO trees contrary to WDC saved policy EN12.

## WD/2021/0203/P04 HEMPSTEAD FARM, HEMPSTEAD LANE, UCKFIELD, TN22 3DL

Change of use of agricultural barn to 2no. 4-bedroom larger dwelling houses.

**P50.04.21** It was **RESOLVED** to **object** to the application on the following grounds:

- Access to the site, being a very narrow lane, would not be suitable for construction traffic nor would it be suitable for any additional private vehicular movements. It is also a popular lane for walkers, used to access Sandy Lane and the introduction of vehicular movements on such a narrow lane would be a danger to pedestrians.
- The Change of use from agricultural to residential would set a precedent for further residential development.
- Concerns that the loss of use of the agricultural structure would make the surrounding fields and facilities redundant for agricultural use in the future.

A member also drew attention to the fact that the owners of Hempstead Oast stated that the boundaries within the application were incorrect and this would be something that needed to be checked.

It was also noted that when Sussex Horse Rescue had in the past wanted to work on the barns, they had to follow very strict guidelines. A member subsequently gueried whether the barn was listed.
