#### 1.0. DECLARATIONS OF INTEREST

Members and officers were reminded to make any declarations of personal and/or prejudicial interests that they may have in relation to items on the agenda. No declarations of interest were announced.

EL.49.01.22 It was RESOLVED that the minutes of the meeting of the Environment and Leisure Committee held on the 15<sup>th</sup> November 2021 be taken as read, confirmed as a correct record and signed by the Chairman.

Ridgewood play area patch repairs had been completed at a cost of £11,975. No further action.

#### FC.64.01.21 – Tree planting programme

Trees have been ordered at a cost of £974 for the planting season during Winter 2021/22. No further action.

#### 7.1 To note the current position of the Town Council's Estates

Members noted the report.

#### 7.2 To consider a street lamp outside 21 Mount Pleasant

Since this was an unadopted road, one member asked if it would be necessary for the purpose of repair on this lamp to meet the new criteria for East Sussex Highways. It was pointed out that this lamp did not meet the required specifications and would therefore need to be replaced, or taken away.

Members had already been informed in a previous meeting that any lamp installation would now require a new lighting design and the Town Council would need to meet those costs which could result in the need for three to five further replacements within this vicinity.

Although this was an unadopted road, this stock was managed by East Sussex Highways (ESH) and so in terms of reducing risk with liability, with a new lighting design they would have to treat this lamp as any other and would be responsible if anything were to happen.

ESH had recently advised however that there could be issues with increasing the number of columns in this area due to permissions and restrictions of space. The difficulty could be that this particular residential area was a very small area behind the main road, although it was near to the footpath off Framfield Road so there could be a concern for residents' safety going to their cars after dark.

Members agreed that the preseding factor must be residents' safety against the cost of a new lighting survey. Also, it was argued that if the light were to be taken down and nothing considered in its place, liability would come back to the Town Council, although ultimately it was a shame that the lamp could not be replaced like for like.

Members proposed that since we had a duty of care, we should consult with the residents first with a local survey to asked for any suggestions before any decision is made. It was also highlighted however that residents needed to be

made aware that if a lighting survey were to be carried out, we may be legally bound to then apply that lighting so they could end up with more lighting that we were obligated to provide which might not be the wishes of all residents to have community LED lighting, for example. If residents were against this then then perhaps something outside of the norm could be discussed instead.

Other suggestions included maybe finding out if there was any room to remove and replace the lamp with some kind of art installation such as a Victorian style lamp, or, maybe working with that particular resident who resides on that gable end and having some kind of sensor light and asking them to pay something towards the electricity.

The Town Clerk pointed out that so far, two different households had reported the lights out with concern that this was taking a long time to be remedied and had been advised that the procedures had changed with ESH and we had to take this further. One property backed on to the light and the other was nearby.

The Chairman concluded that the report had provided the basis of what was being asked and so this could be used to inform local residents why we were contacting them and to ask them for a reply.

#### EL.50.01.22 Members noted the report and RESOLVED to:

(i) agree to a local survey being sent to residents who live at Mount Pleasant in the first instance (with a set deadline) asking if they can provide any thoughts and suggestions on the street lighting in this area.

#### 7.3 To consider enquiry relating to litter left at the Ridgewood MUGA

The report mentioned that potential litterers could be members of clubs in the town so whilst we could contact Uckfield College, one member said that local sports clubs such as the Uckfield Grasshoppers may have a code of conduct that also included behaviour outside of the club which could be impressed upon for social misbehaviour. Although this kind of threat would be a last resort it was thought that this may help to increase the pressure on social responsibility.

Another member said that he had been a football coach for both Grasshoppers and Maresfield football clubs and that both clubs would have had their own code of conduct but did not necessarily stretch to make use of areas that were not particular training grounds, although he agreed that it might be worth just reminding club members to be aware of their surrounding areas and take their litter home if no bin was provided.

Members also asked if other social media platforms such as Active Uckfield could be invited to remind their members to use the town's facilities aross the town (not just Ridgewood) including assistance from local press coverage in The Voice asking people to either take their rubbish home or use a bin provided.

With regard to the request for signage at the Ridgewood play area and timber shelter, members discussed whether this would be enforceable and that residents could not be asked to leave play parks at certain times. There was no byelaw to suggest that this would even be enforceable and we did not have park attendants like in some other areas of the country.

One member suggested it might be better just to ask users to be mindful and considerate to local residents on all of our open spaces since the Town Council had spent a lot of money on our local parks.

Another member highlighted said that we would have to consider fairness to all our residents and that trying to stop teenagers congregating in local parks on a summer's evening would not be at all fair to their sector of the community.

The cost of signage was considered a bit of an overkill in the first instance by one council member who proposed placing a memo instead to local primary and secondary schools asking them to pass on the local Town Council's concerns and wishes that users treat the parks with respect and be considerate of its neighbours.

The Chairman agreed and pointed out that it largely came down to respect for others which is something that seemed to have been lost since the days of the 'Keep Britain Tidy' campaign and that we did not seem to have a problem in some parks and more others.

Members also requested for officers to find out the cost of having two signs (at Ridgewood) and to decide this at a later date.

#### **EL.51.01.22** Members noted the report and **RESOLVED** to:

- (i) agree to apply for a licence for a bin to be installed at the Ridgewood MUGA, and:
- (ii) ask local sports clubs and schools to ask their members to be mindful and respectful of litter and to either take their rubbish home or use the bins provided in the town, and;
- (iii) request officers to find out the cost of signage for Ridgewood play area.

## 7.4 <u>To consider a request for a litter bin from the Scarlett's Close Residents'</u> Association

One member said he often went on walks in this area and did not recall there being much litter around although another member said that it might be wise to reinstate a bin here for dog walkers.

Members agreed on balance that we could not just keep installing extra bins around the town as we had to be mindful of the increased collections and costs involved. Also, given that this bin had been removed previously, we may be provided with reasons for this whilst applying for a new bin in this location.

#### **EL.52.01.22**Members noted the report and **RESOLVED** to:

(i) agree to seek costs for the installation and emptying of a new bin on the ESH verge adjacent to the Bell Lane allotments, provided that permission was sought.

#### 8.0 LEISURE

## 8.1 Revised proposals for changes to the Allotment fees and charges from 1 April 2023

One council member, Cllr D. Bennett, declared an interest as an allotment holder and so he was excluded from taking part in these discussions.

Having reviewed the contents of the report and accompanying powerpoint presentation from the allotment conference on 10<sup>th</sup> November 2021, these recommendations had highlighted the true costs of managing the allotments which had been heavily subidised by the Town Council over the past few years. Members agreed that this was not sustainable.

Although there had been one or two concerns received from tenants, overall the response from tenants about the new proposals had been more positive with a

clear view of the problems being faced by the Town Council whilst trying to cover its various running costs.

A member of the Allotment Working Group explained that they had recognised that better communication was needed with our allotment tenants going forward and that lessons had been learnt.

Members were in support of the new set of proposals. There would be a fee for each plot based on plot size and separate water charge (as it is now) but the new structure would include an additional administration charge of £15 per plot (per annum), regardless of size. This would come into effect on 1 April 2023 and run for that financial year, with invoices then being sent out every April. This would include an interim charging period between October 2022 and 1 April 2023 (with no administrative charge).

#### **EL.53.01.22**Members noted the report and **RESOLVED** to:

(i) agree to the proposed changes for fees and charges for allotments from 1 April 2023 as set at the Allotment Conference on 10<sup>th</sup> November 2021.

## 8.2 <u>To consider if Uckfield Town Council wishes to hold an event which can be incorporated within Uckfield Festival week 2022</u>

The Chairman announced that as he was the Town Council representative on the Festival Committee, although he liked the idea of getting involved with the festival, he felt that this year was not the right time as the Town Council had committed to two events already; Weald On The Field and Uckfield Revival. He said that unfortunately it would be difficult to fully commit to this taking into account starting issues and the budget and suggested for members to perhaps revisit this next year instead once they were in a better position.

Members agreed that this was a sensible suggestion as the Queen's Platinum Jubilee was set for this year, although this did not prevent them thinking about ideas and proposals in September in time for the budget setting.

The only issue raised was that Uckfield Festival committee would have their AGM committee in November when new members might join up and decide not to go ahead, although this was stipulated to be too late now to provide any new ideas for this year.

The Chairman proposed that he would report back to the Festival Committee this week and re-look at this in September with the understanding that if they wanted some proposals that members would have ideas in mind by then.

#### TO CONSIDER HEDGE LAYING IN LUXFORD FIELD - WINTER 2022

#### 1.0 Summary

1.1 This report proposes more hedge planting on the boundaries of Luxford Field.

#### 2.0 Overview

- 2.1 To enhance the biodiversity of Luxford Field, in line with Uckfield Town Council's climate change policy and enclosing the field slightly will help in creating a park like atmosphere. This proposal is to plant a hedge row on the Western edge from Holy Cross Primary School path up to the play area along the existing fence line.
- 2.2 The Northern boundary will also be included between the play area and north eastern footpath. This will create a natural boundary between the field and car park.
- 2.3 It is proposed that the Eastern boundary be planted between the two vehicle gates along the existing fence, between the trees.

#### 3.0 Expenditure

3.1 Pre-planned planting is costing £2,979 + VAT for Framfield West Road allotments. The additional planting at Luxford field would be £2,081 + VAT. The total in the budget for allotment fencing in Earmarked reserves is £6,803. This would leave £898 remaining in this budget.

## PROPOSALS FOR TREE PLANTING AND THE NATURAL REGENERATION OF BOOTHLAND WOOD

#### 1.0 Summary

1.1 This report provides a summary from our Ranger regarding tree planting at Boothland Wood. The intent is to increase the range and diversity of tree stock owned by Uckfield Town Council giving improvements to residents in terms of amenity aesthetics and the host of environmental services trees provide.

#### 2.0 Site one: Ridgewood recreation ground

- 2.1 Much of the recreation ground is regenerating naturally where it is uncut. However, one particular area remains free of saplings. This is possibly because this area is some distance from existing trees however, the area is exceedingly wet. The area has been planted with transplanted trees at no cost to the council. It is thought that the addition of some wet ground specialists will help with the hydrology of the site and future flooding episodes especially in light of proposed developments.
- 2.2 Two swamp cypress (*Taxodium distichum*), a deciduous conifer absolutely ideal for the wet conditions encountered on the recreation ground. The tree grows between 10-40m and is a native of the South Eastern United States. The tree is adapted to waterlogging being able to grow in standing water for many months.
- 2.3 One alder (*Alnus glutinosa*), a native deciduous tree, a good pioneer and regenerator of brownfield sites. This is a riparian species that tolerates waterlogged conditions well.
- 2.4 Alternatively, we could plant a Dawn redwood (*Metasequoia glyptostroboides*) these grow to 20m on moist urban sites. This tree is endangered in its home territory and is another deciduous conifer.
- 2.5 This site with stakes and soil amendments would cost between £205 and £210 to plant. Conifers are favoured over the alder. Alder is a fine tree with many wildlife associations but is also subject to phytophthora diseases and is considered "under threat" by the Woodland Trust. Conifers would fit within the local area which features many specimen conifers. Alder would likely have a foreign provenance unlike conifers.

#### 3.0 Site two: Victoria pleasure ground - skate park and MUGA

3.1 Trees have been selected to provide shade, shelter and to dampen noise from these popular recreation areas.

#### 3.2 Vandalism

Despite the attraction for young people the area is rarely vandalised, perhaps being too exposed. However, trees at this site would be protected with tree guards.

- 3.3 Victoria Pleasure Ground boasts a fantastic array of specimen trees, the following aims to create diversity to the range of conifers already present. Conifers have been chosen as there are presently a range of young and semi mature broadleaf trees on site but no succession is evident for conifers.
- 3.4 One deodar cedar (Cedrus deodara) A conical cedar reaching 25m in height and hardy.
- 3.5 One blue atlas cedar (Cedrus atlantica glauca). A striking blue cedar up to 30m with a 15m spread.
- 3.6 Two giant redwood (Sequioa sempervirens). A tree which is oddly common in Uckfield, fast growing and fire resistant. Soil conditions may necessitate a change in species selection.
- 3.7 One western red cedar (thuja plicata. A very hardy tree which reaches 15m.
- 3.8 With amendments these can be planted for £420 not including support as these will be constructed along with the tree guards. It is calculated that this would cost around £100. The total cost for these plantings would reach approximately £1132 though species are subject to change.

#### 4.0 Budget overview

- 4.1 There is a budget remaining of £1,226 towards tree planting, which these funds can be allocated towards.
- 4.2 diagram below to show tree planting budget:

#### 5.0 Regenerating Boothland wood



Image 1: Boothland Wood in 1888

- 5.1 As can be seen in the above image in 1888, Boothland wood extended considerably further than it does now. Boothland wood is ancient semi natural woodland and as such is one of the rarest environments in the United Kingdom with only 2.5% of the UK being ancient woodlands.
- I propose allowing the grass strip which is left long on New Barn field to fully regenerate into woodland. This will need signage to inform park users as to what is happening. The areas on Fin field where this is happening have been brought to my attention as being "rough" and "untidy".
- 5.3 I understand that the developers to the south of the wood are proposing planting up areas around the wood. I suggest that we ask them to allow any "buffer zones" to regenerate naturally and allow the seedbank that already exists and colonisation from the existing wood to slowly turn the areas left into climax woodland. As can be seen the existing planting schemes of uniform rows of imported low quality whips would be entirely inappropriate around and ancient and complex eco system. If they insist on planting it would be good if the Town Council could take this project from them (*still funded by them of course*) to ensure that it is conducted according to the needs of the site and in the interests of the continuation of Uckfield's natural heritage.

#### 6.0 Conclusion

6.1 Speaking to English Woodlands they recommend planting in late February as the soil conditions are both drier and warmer. They were sceptical about giant redwoods taking on Wealden clay as they prefer drier conditions. It might therefore be an idea to just go with one of those and monitor its growth.

### TO CONSIDER A PROPOSAL BY THE UCKFIELD & DISTRICT LIONS CLUB FOR TWO BENCHES ON THE WESTERN SIDE OF LUXFORD FIELD

#### 1.0 Summary

1.1 At the beginning of this year, Uckfield Town Council were approached by the Uckfield & District Lions Club to enquire about the possibility of placing two new benches on the western side of Luxford Field to commemorate the Queen's Jubilee this year.

#### 2.0 The Queen's Jubilee commemoration

- 2.1 To mark this important occasion, Uckfield & District Lions Club had a meeting where a number of ideas were considered and discussed, and they decided that they would like to gift the benches to the popular and central open green space in the town, Luxford Field.
- 2.2 The Lions would be interested in placing two benches that would either be the same design as the existing benches or, if the company have designed one, something to go with the Jubilee theme, although they would still need to look at this part.
- 2.3 The Lions have recognised that it would not have been a sensible suggestion when the playground was in need of updating and also, since the new playground has been installed towards the north end of the field, having seating on this side nearest the park would benefit those who visit the park frequently such as grandparents to oversee their grandchildren playing in the park.
- 2.4 They have noticed that there is one of the old benches on the Holy Cross School fence and wondered if another bench on that side would be beneficial, and so propose the following:
  - a: replace the existing wooden bench for a metal bench, and;
  - b: add another bench between that one and the new play park.

#### 3.0 Timing of bench installation

3.1 They would like to try and get the benches installed by June ready for the Queen's Jubilee, so they would like a decision made as soon as possible.

#### 4.0 Current bench condition

4.1 The current condition of the bench on the Holy Cross School fence is detailed in the photos below:

#### TO CONSIDER REPAIRS TO CRICKET NETS AT VICTORIA PLEASURE GROUND.

#### 1.0 Summary

1.1 Anderida Cricket Club have approached the Town Council to assist in financially contributing towards repairing the damaged and vandalised cricket nets at Victoria recreation ground.

#### 2.0 Costs involved and budget

- 2.1 The total cost for repairs is £2,349.57+VAT. Anderida Cricket club have offered to contribute half of the total amount towards repairs at £1,174.78+VAT and are asking the Town Council to contribute the remaining costs of £1,174.78+VAT. The nets are only used by Anderida Cricket Club during the summer cricket season.
- 2.2 The Town Council had a combined budget of £23,500 in 2021/22 made up of the playing fields and pitches nominal code and the covid play area spraying new initiative.
- 2.3 Total expenditure up to 7 February 2022 is £23,860.51, making an overspend of currently £360.51. The Town Council has £4,884 in earmarked reserves under playing fields and pitches, of which the 50% nets contribution of £1,174.78+VAT could be allocated towards this. However, this would only leave £3,709.22 in the earmarked reserves for playing fields and pitches in case of any over spend before year end.

#### TO CONSIDER BLOCKING ACCESS - NORTH OF HARLANDS PLAYING FIELD

#### 1.0 Safety issue detected

- 1.1 This report refers to safety concerns raised by the Newtown Action Group. At a recent meeting, concern was raised by some of their members regarding a safety problem between the playing field and the group of bungalows in Selby Rise.
- 1.2 Newtown Action Group members have raised their concerns regarding the sheer drop from the playing field into the gardens of the bungalows (see pics below).
- 1.3 The concern is that children playing in this field could try and retrieve a ball accidentally kicked into the hedging, not knowing that there is a sheer drop into the gardens below.

#### 2.0 Area of concern

2.1 The area of concern is located at the rear of the two properties (i) Clintz, Selby Gardens, Uckfield, TN22 5EF (Image 2) and Dale View, Selby Gardens, Uckfield, TN22 5EF (Image 3) (highlighted below for reference in yellow).

2.2 It is a large drop on the far side, there is almost no access from the Town Council side except for two places and one involves crawling through a thorny hole in the hedge. The other shows no sign of foot traffic.

2.3 There are signs of activity behind the Town Council's hedge which seems to be accessed from the gardens below (see rope pic below) and some of the under growth has also been cut back.

#### 3.0 Looking for ideas and suggestions

- 3.1 The Newtown Action Group were asking if it would be possible for the Town Council to erect some form of fencing behind the hedging.
- 3.2 They also said that they would welcome any help and suggestions on how they should proceed with this matter and also said that they would look forward to working closely with the Town Councillors in the future.

#### 4.0 Possible suggestions

- 4.1 If a fence was erected, this would block the gate and rope access so it may be more appropriate for the Residents' Association to speak with these two properties first to establish what they would like to see.
- 4.2 If a fence was erected, there are concerns children could still climb, so a good alternative perhaps would be to install some signage instead stating 'Danger, steep drop' or similar to make anyone in that area, aware of the risks.
- 4.3 The Grounds staff have five posts for post and rail in stock at 4ft in height which would be enough to enclose the two gaps through the hedge. If the whole northern boundary adjacent to the pathway of the field was fenced, this would cost in the region of £3,500. There is no budget currently available set in this financial year or 2022/23 to cover this cost.
- 4.4 An alternative solution is to reinstate the hedging in the gaps, however there could still be a risk with no signage advising members of the public.

### REPORTS FROM WORKING GROUPS: CLIMATE CHANGE STEERING GROUP

#### 1.0 Summary

- 1.1 The Climate Emergency Steering Group has predominantly focused on getting the Uckfield Green Partnership up and running in recent months. Uckfield Green Partnership (UGP) appears to be going from strength to strength, with between 12 and 15 representatives attending each meeting.
- 1.2 UGP is in the process of setting up a structure. A Chair (Angie Smith) and Vice Chair (Roger Isaacson) have been elected and we are actively looking for a Secretary, Young Person's representative and Comms/Media Officer(s). We have also set up three working groups focusing on:
  - 1. Energy and transport
  - 2. Sustainable living
  - 3. Natural capital
- 1.3 UGP is current formalising a mission statement for the group. Action in Rural Sussex representative, Chiara Vagnarelli, has put together a community engagement plan. We have now established a Facebook group, and have a regular slot in Uckfield Matters.

#### 2.0 ECO EXPO 2022

- 2.1 Aside from this, Uckfield Town Council are planning to host an 'ECO EXPO 2022' on Saturday 30 April 2022. This is intended to be a showcase of local green-focused businesses, designed to show residents how they can live more sustainably. Karen Bedwell is the driving force behind this, but if any councillors are able to help with putting the Expo together, particularly attracting stall-holders, this would be very welcome.
- 2.2 The event will take place in the Weald Hall of the Civic Centre, Uckfield from 10am until 4pm (TN22 1AE) and we hope to attract a wide range of local businesses and local residents. We hope this event will help to inform people of the small changes they can make to their home and lifestyles and how such changes can help to make a difference to our environment.
- 2.3 The event will be managed and advertised by Uckfield Town Council and will assist with promoting all businesses involved. There will be a small admin fee of £25 to cover the costs of running and staffing the event.
- 2.4 We have a limited number of spaces for this event and it will be on a first come first paid basis. Invoices will be issued once the place has been booked and

payment can be made by BACS, cheque or cash to Uckfield Town Council (details will be available on the invoice).

- 2.5 Access to the Weald Hall will be provided from 8am on the day to give everyone time to set up. 10-hour free parking is available in Luxford car park located just north of the Civic Centre off Civic Approach at postcode TN22 1AL.
- 2.6 Uckfield Town Council hopes this will be the first of many ways in which we can help to improve the effects of climate change for future generations both locally and nationally and we hope that local businesses will be interested in attending the event.

## REPORTS FROM OUTSIDE BODIES: UCKFIELD RAILWAY LINES PARISHES COMMITTEE

#### 1.0 Summary

The bi-monthly meeting of the group on 12 January was held remotely by zoom. However, following the lengthy holiday shut down over the Christmas period there was not a lot of content to discuss.

The continuing engineering works at Victoria which have closed the terminal since the beginning of the holiday break are still ongoing. This affects our line in as much as the trams terminating at East Croydon and then passengers having to change trains for the onward journey to London Bridge. All this time, Southern Trains are currently going to London Bridge only and there is often a delay in the connection.

Apparently, Southern are not now issuing printed timetables, these are available on the website but only one week at a time. It was considered that the current service was generally satisfactory but that the users' uptake was very low again following the governments directive on home working and the holidays.

The new lift at Eridge is now working. However, ESCC have not brought forward the disabled parking at the station despite all of the users' pressure. Works to the new footbridge and lift at Crowborough have commenced.

There are meetings held by the Brighton/Seaford line users' group. GTR Stakeholders and Restoring Your Railways during February at which our group will be represented.
