# PLANNING: ROLE OF TOWN COUNCIL

Planning authorities must inform parish and town councils of applications affecting its parish. Whilst parish and town councils do not have the power to grant or refuse planning permission, as a statutory consultee our role is defined in law and our views must be considered. The local planning authority for Uckfield is Wealden District Council's (WDC) planning department.

Uckfield Town Council is a statutory consultee on:

- the development plan
- local plans
- structure plans

#### **Plans Committee**

The Uckfield Town Council Plans Committee consists of seven town councillors who meet every three weeks to review and comment on planning applications that have been submitted to WDC, prior to them making a decision The gathering of local knowledge by UTC plans committee is important. We can offer background insight on local ecology, flood risk, highway concerns, parking, loading, turning, loss of light, changes to the street scene and neighbourhood concerns. We can provide local detail that planning officers who are unfamiliar with individual sites are not always aware of. As a consultee we also have input in the shaping of a local Neighbourhood Plan. input into the Wealden Local Plan and provide feedback on highways matters. Sometimes it can feel a very frustrating



role, especially when local knowledge has not been taken on board. However, it is important that we are there to represent residents' views.

Uckfield is currently facing growth on an unprecedented scale. We are expecting to see large scale applications for consultation in the next three months and it is important that residents take the opportunity to share their views with UTC Plans committee and Wealden District Council.

### LAST MONTH IN YOUR COUNCIL

### **Update on The Dene**

On 25 July, Full Council were presented with an update on the Dene, off Brown's Lane on Manor Park. The Dene was originally part of the Lord Nevill Estate and is a steeply sloping piece of land which creates a beautiful vista from Manor Park towards Buxted Park and Views Wood. At present the land is owned by Buxted Parish Council, but they are looking to dispose of this and one other site in order to raise funds to develop a community hall. The grassed area attracts a variety of wildlife including deer and foxes together with a range of birds.

### **Asset of Community Value**

As a result of the land being registered as an Asset of Community Value with Wealden District Council, Buxted Parish Council were required to follow specific procedures in their investigations to dispose and/or sell the site. This means that time is given for community interest groups to express an interest during an interim moratorium period. The deadline for expressing an interest was 3 August 2022.

Members of Uckfield Town Council

were keen to see the Dene protected as an important green space within the town and ensure that the open plan garden estate layout of Manor Park is retained. For that reason, the Town Clerk was tasked with writing to Wealden DC to register Uckfield Town Council's interest before the deadline and register as a potential bidder for this asset. If accepted, this would mean that the clock would stop and a full moratorium period be undertaken until December 2022, whereby Uckfield Town Council could explore further details with regards to the land, in terms of the title deeds, maintenance and purchase price. Wealden DC have confirmed receipt of the council's letter and advised that the full moratorium period would now be put in place until December.

### Looking to the future

Moving forward, Uckfield Town Council will now arrange a meeting with Buxted Parish Council to obtain further details about the Dene, and liaise with the Town Council's solicitors to understand the full liabilities within the title deeds for the site.
