Our Town Mayor's Annual Review of 2025-26

Welcome to the Annual Town Meeting.

This meeting provides an important opportunity for residents and Town Councillors to come together, share views, and discuss the issues that affect our town and the surrounding communities that rely on Uckfield as a vital hub for services.

Each year, our Councillors and officers work diligently to ensure that all statutory parish responsibilities are fulfilled. At the same time, we strive to support our residents and enhance Uckfield as a strong, vibrant, and welcoming community.

For full transparency, details of all Councillors, committee meetings (agendas and minutes), and key documents - including our Strategic Plan, Property Asset Management Plan, and Annual Budget, are available to view on the Town Council website.

This year, the Town Council has taken the decision to increase the precept by 7.55%. This reflects the significant and growing portfolio of assets that we own and manage on behalf of the community. This includes 10 buildings, 17 open spaces, 8 play areas, 7 recreation grounds with football and cricket pitches, 4 woodlands—two of which are ancient, 6 allotment sites, 2 local nature reserves, 192 streetlights, and 72 litter bins, along with other essential street furniture.

Our key priorities for the coming year include the continuation of asset upgrades – built and green. This involves focus on our sport and recreational facilities (play areas, including the skate park and sport pitches) as well as progressing building maintenance programmes to ensure our properties are compliant, in the right condition, and preparing for growth within the town with new facilities.

Following a staff restructure initiated last year, we are pleased to welcome new members of staff. These changes are designed to support the town's continued growth and ensure we can maintain and enhance our facilities both now and into the future. It remains very important to me that, as residents ourselves, we recognise the financial challenges facing many in our community. By setting aside political differences, we can work collaboratively to make decisions that benefit all who live and work in our growing town.

It has been a great honour to serve as Mayor for a second year, and to witness first-hand the outstanding work carried out by the volunteers and charitable



organisations across Uckfield and the surrounding areas. These groups provide invaluable support to people of all ages facing a wide range of challenges. Uckfield is truly a town with a village spirit—time and again, when help is needed, people step forward to offer it. When reflecting on the past year, some of our key achievements include:

- A clear and successful audit for the 2024/25 financial year;
- A review of staffing to strengthen resources;
- Enhanced corporate training programme;
- Implementation of a new HR contract;
- The award of community grant funding to 25 organisations;
- Installation of a new Town Clock on the High Street;
- Improved festive lighting within the Town Centre;
- CCTV enhancements in the vicinity of Luxford Field/Car Park;
- New floral displays on Tesco roundabout;
- Successful delivery and support to key events, including VE Day commemoration and VJ Day beacon lighting, Weald on the Field, Remembrance services, and Late Night Shopping;
- Ongoing support to charitable events, fundraising, and community activities;
- New compliance and utility contracts to improve efficiency and reduce costs;
- Fire safety upgrades, including new doors and signage;
- Installation of Wi-Fi in Foresters Hall;
- Commencement of refurbishment works at the Signal Box;
- Installation of a new artificial cricket wicket;
- New manoeuvrable goalposts at Victoria and Harlands;
- Pitch renovations and equipment reviews;
- Progress towards a Football Foundation application for a 3G pitch;
- Full upgrade of Victoria Play Area;
- Replacement play area equipment at Hempstead Recreation Ground;
- Appointment of new contractors for play area inspections;
- Continued delivery of the Woodland Management Plan, including work to address ash dieback;
- Comprehensive tree surveying and digital mapping of works undertaken and survey outcomes;
- Ecological assessments of Boothland Wood and our nature reserves, including dormouse and bat surveys;
- Conservation work at Harlands Pond;
- Management of flora and fauna in Boothland Wood;
- Introduction of a new memorial bench scheme;
- Preparations for cemetery expansion;

Looking ahead, 2026 will bring new challenges, particularly as plans for devolution begin to take shape. As Councillors, we remain committed to representing the views and interests of all of our residents to the very best of our ability.

General Purposes Committee

Firstly, can I record how much I appreciate the support and engagement of my fellow councillors on the General Purposes Committee, and members of staff for all of their contributions in reaching, what I hope, are sensible, beneficial, long-term and practical decisions, on all of our deliberations.

Our committee looks after, and is responsible for the Town Council's extensive property portfolio, the Council's financial matters (considered and recommended to us for approval by Finance Sub Committee) and also staff and employee welfare matters (considered by Personnel Sub Committee).

The Town Council has a property portfolio of some 66 assets comprising of buildings, allotments, nature reserves, play areas, open land, recreation facilities and the cemetery which all need constant inspection and maintenance. The current value of which is over £5million.

The Town Council has an annual budget this year in excess of £2million, which covers all aspects of the Council's operations. Many of our assets produce revenue to contribute towards our income; thus, reducing the amount of the precept borne by council tax payers. All levels of income and expenditure are fully scrutinised by both the staff and councillors. In addition, the accounts are inspected quarterly and annually by qualified external auditors and accountants. Credit is due to our Town Clerk, Assistant Town Clerk & Responsible Financial Officer and wider staff for the high level of approval received on the standard of the financial controls operated by the Town Council.

Again, credit is due to our Management Team on the manner and level of employee satisfaction within the organisation. We have a total of 32 members of permanent staff together with several casual operatives who are employed on an as needed basis. The length of service and very low staff turnover rate is testimony to the degree of satisfaction by all staff of their employment conditions.

Uckfield is rightly proud of the social and community spirit within the town and the Council are pleased and grateful to be able to support the many and varied organisations within the area through its Community Grants Programme. This year we have financially supported 23 different groups in the total sum of just under £19,000 together with the three Service Level Agreements to Wealden Citizens Advice, Wealden Volunteering and the Uckfield Bonfire & Carnival Society all of which assists them in their work in making Uckfield the superb engaging community it is.

Throughout the year continuous improvements to compliance and maintenance have been made across our buildings and facilities to ensure that they remain fully compliant,

safe, usable and pleasant facilities for the users and members of the public. Our thanks go to our Facilities and Compliance Manager and all of his colleagues for dedication to detail and regulation.

For those who have visited Luxfords Restaurant during the year you will have experienced the welcoming attitude of the staff, varied menu and excellent quality of the food not forgetting of course the many and diverse entertainment selections offered in the evenings and at weekends, within the Civic Centre.

We are so lucky to have the knowledge and expertise of our Hospitality Manager and congratulate her and the staff on all their efforts to encourage and promote this facility.

Finally, I would wish to thank my fellow councillors who voted me into this position and trusted me with the role of Chair and to all the staff who, as I said earlier, have supported, advised and assisted all of us in what I hope is to the overall benefit of the town and all its residents, both now and in the future.

Environment and Leisure Committee



As we come to the end of my second year as Chair of the Environment and Leisure Committee, I would like to thank the Vice-Chair, Councillor Bernadette Reed, and the Committee members for their support, hard work and some lively discussions.

I would also like to thank our Clerk, Rachel Newton who does a great job of driving our work forward.

The Environment and Leisure Committee deals with important considerations relating to the management of our estate, council equipment, leisure activities and open spaces. Therefore, decisions made by the Committee impact on the lives of all of us, as residents of Uckfield.

This year we have continued to work hard to conserve and protect our green spaces across the town. We are fortunate to own two very special areas of ancient woodland (Boothland Wood and Nightingale Wood), which have faced challenges this year, in the form of both Ash Dieback, and impacts from development. We are in the third year of our Woodland Management Plan, which meant losing some infected trees, but we continue to plant new trees, as part of our 'tree for a tree' initiative. We have also seen the three new orchards in Victoria Pleasure Ground (New Barn), West Park and Ridgewood Recreation Ground maturing. I'm looking forward to sampling some of the fruit from the new orchards.

Those of you who use Victoria Pleasure Ground and Boothland Wood will have seen that the Council is in the process of carrying out protective works to safeguard this irreplaceable habitat. This entails installing 1.2-metre-high stock fencing along the New Barn field side of the wood, with pedestrian gates and badger gates within the fence line. A temporary footpath will create a looped walking route; guiding visitors around the western edge and back towards Victoria. A section of the south-west corner of the wood will be closed to allow the habitat to rest and recover.

Over recent months, we have been carrying out detailed ecological appraisals of the woods, as well as our nature reserves – the survey has confirmed the presence of dormice in the woods, for example – dormice are a legal protected species. We are very conscious of what Boothland Wood means to our town and it is essential that we act now to ensure that future generations can enjoy this beautiful space, with its wealth of flora and fauna, too.

The Council has invested in specialist software to help us manage the health and works to trees under our protection. This software helps us with mapping survey data and records of work undertaken, so that the grounds staff know how best to care for each tree.

Another special piece of land that the Town Council looks after is our cemetery in Snatts Road. This year the Council has been working towards an extension of the cemetery: a new Y Section, to ensure we can keep up with local need. The new layout will provide for 253 burial plots and 827 plots for ashes, with fifty per cent of those areas being allocated for secular and non-secular traditions. My thanks go to Rachel Newton, the Council's Senior Administrative Officer, who looks after the cemetery, as she is always very sensitive to the wishes and feelings of those who have loved ones interred there.

The Environment and Leisure Committee also look after several sporting facilities in the town and I am pleased that we have made quite a few improvements to our facilities this year, including:

- A new artificial cricket wicket and nets at Victoria Park
- Installation of new moveable goal posts at Harlands Park and Victoria Park – we are also finalising the installation of toilet facilities at Harlands Park, to enable it to be used for girls' football
- We are finalising an application to the Football Foundation for funding (also supported by Wealden District Council) for a 3G pitch – Victoria.

Our play facilities benefited from upgrades this year too. It was a pleasure to attend the official opening of the brand-new playground at Victoria Park earlier in the year and it is certainly being well used by local families. We also replaced the zip wire at Hempstead Field with new equipment. We know the old zip wire was a favourite, but unfortunately in recent years it was often out of action, due to maintenance issues or vandalism. We hope that the replacement Coco Wave Swing is equally exciting!

This year also saw another successful Weald on the Field delivered in August. This event is an annual fixture in the calendar, that can only happen because of the hard work of Council staff, aided by Councillors. This year's Weald on the Field was the ninth annual festival, and was boosted by beautiful, sunny weather, making it the most successful yet in terms of visitor numbers. Visitors crowded around the stage, enjoying food and drink from a range of local providers, and music from acts including The Management, Repeat Offenders, The Midnight Project, The Carnaby Brothers and headliners, Dynamite. We are all awaiting Weald on the Field 10 this year, with anticipation.

Climate change and biodiversity loss are important considerations for the Committee and drive work such as our tree planting programmes. The Committee works closely with outside bodies such as the Conservators of Ashdown Forest; it also works internally to find green solutions where possible, supported by Council's Climate Emergency Steering Group.

For example, this year has seen starting to upgrade our solar panels on the Civic Centre. In March we held our second Eco Expo at the Civic Centre, where we had

stallholders demonstrating different products ranging from solar panels to bees wax wraps. We are grateful to have the support of the Council staff, the Hospitality team at Luxfords Restaurant, the Town Ranger, and the Grounds staff in pursuing a green agenda.

Plans Committee

Uckfield Town Plans Committee are still working hard as a planning consultee within the local planning system.

We review each application in detail; considering local knowledge, adopted local planning policies, as well as national planning policy such as the National Planning Policy Framework.

We have also, with the support of the Environment and Leisure Committee, just submitted a comprehensive response to the focused Wealden Draft Local Plan which was out for public consultation. As the local planning authority for this area, Wealden District Council are required to prepare a Local Plan which sets out a long-term spatial vision. It also focuses on themes such as housing, climate change, the natural environment, heritage, the economy and infrastructure. With the extent of growth anticipated for the Uckfield area, we were keen to consider the draft plan in close detail. Uckfield will need to have the right facilities and infrastructure to support this level of growth; the often-suggested tweak of a traffic light operation by applicants is not enough!



It was disappointing to see the loss of much needed community infrastructure within the Ridgewood Farm application for Phase 2 (750 dwellings). As we all know Uckfield has a thriving community and a number of local organisations are struggling to find space to support their voluntary groups and the various community events we see within our town. It would have also created a positive link between residents within the urban area and new residents moving into developments on the periphery of the town. On a positive note however, the employment space assigned to this site has also been approved and we hope that it will be built out soon to ensure Uckfield has the right commercial units to support both new and existing business.

Recently an application submitted by Taylor Wimpey for 100 dwellings just south of Victoria Football Pitch went to Wealden District Council's Major Plans Committee for approval. The Town Council tried to seek a deferral as we felt a number of points hadn't been fully evaluated against the concerns we had previously raised. Despite lengthy discussions however, this application was granted approval. We therefore hope that Taylor Wimpey will engage with the Town Council to ensure this site works and any impact to both Victoria Pleasure Ground and Boothland Wood is minimal, during and after construction.

As a committee, we would like to invite you to our meetings in order to provide your comments through us or directly to Wealden District Council. The Town Council's Plans Committee considers (as a consultee) all Uckfield based applications. A list of the applications being considered can be viewed on the agenda for each meeting, which are published on our website. We need your voice, and your input, to fully understand the

setting of each application, and help committee members prepare a constructive response which reflects the views of our community.
